

Texas Instruments Inc. (TXN): Strong results and guidance suggests that the analog recovery is continuing

Key stock takeaways: We expect the stock to trade higher following a quarter and guidance that came in well above the Street. We believe expectations were somewhat elevated given management's constructive commentary at recent conferences, and based on our conversations we believe most investors were positioned more constructively ahead of the quarter. We see the strong recovery in the industrial end market as a particularly encouraging read-across for the sector. Although we continue to see a recovery across the analog sector (including for TI), we believe peers have managed their inventory levels far more proactively — and hence we believe gross margins are likely to recover much faster for peers (along with significant upward earnings revisions) than for TI. We continue to have a preference for peers (including Microchip, NXP, and Analog Devices) who are likely to see greater upward earnings revisions in the near term, and we retain our relative Sell rating on TXN given the ongoing gross margin headwinds we expect in the coming quarters.

Read-through to our coverage: We expect a positive initial reaction for the analog group, with the most direct read-across for MCHP (Buy) and ADI (Buy) given their relatively high industrial exposures.

Quarterly revenue and EPS are above the Street: TI reported 1Q26 revenue of \$4.83 bn, above GS at \$4.60 bn and the Street (Visible Alpha) at \$4.53 bn. Gross margin of 58.0% was above GS at 56.0% and the Street at 56.2%. Operating margin of 37.5% was well above GS at 33.4% and the Street at 34.1%. EPS of \$1.68 was well above GS at \$1.43 and the Street at \$1.37.

- **End market trends:** TI's 1Q26 industrial revenue increase of over 20% QoQ was well ahead of our expectations – and the company's 1Q revenue guidance of up ~8% QoQ (at the midpoint) suggests a continued cyclical recovery across the supply chain. The company noted that it continues to see the market gradually revert toward trend, with performance accelerating across the quarter. Automotive was roughly flat QoQ, personal electronics was up low-single digits QoQ, communications equipment was up 30% QoQ, and datacenter revenue was up 25% QoQ in 1Q.
- **Inventory levels:** Inventory on the balance sheet was lower (down ~\$100mn) on a sequential basis to \$4.7bn and inventory days ticked 13 days lower to 209, which we view as encouraging. Management intends to manage its factory loadings dynamically in order to manage internal inventory levels according to customer demand. Although we see this trend as a positive for the company's

gross margins over time, we expect TI's gross margin expansion to lag peers as the recovery continues.

- **Margins:** TI's implied 2Q gross margin guidance is for gradual expansion QoQ as the company manages its factory loadings to end demand, which implies gross margins up by ~100bp-150bp in 2Q (we model for 2Q26 GM of 59.4% vs. 58% in 1Q26)—and we expect continued gradual gross margin expansion over the course of 2026.

2Q revenue and EPS guidance is above the Street. TI guided 2Q above the Street on revenue and EPS. Revenue was guided to \$5.20 bn at the midpoint, which is well above GS at \$4.92 bn and the Street at \$4.86 bn. EPS guidance of \$1.91 at the midpoint is well above both GS at \$1.66 and the Street at \$1.58.

Estimate changes. We increase our 2025-2027 EPS estimates by an average of 19% to mainly reflect higher revenue and modestly higher gross margins than we had previously modeled (see detailed estimates below — [Exhibit 3](#)).

Price target. We raise our 12-month price target to \$200 from \$175 prior, which is based on a 25X P/E multiple (unchanged) applied to our normalized EPS estimate of \$8.00 (up from \$7.00 prior given improving earnings visibility). Key upside risks: 1) upside to end-demand across key verticals; 2) a reversal in market share dynamics; 3) better-than-expected gross margin performance and/or opex leverage.

We remain Sell rated on TXN. We still believe that TXN is gradually regaining momentum in its core end markets (i.e. automotive and industrial, ~69% of sales), but we believe Street gross margin estimates remain too high and the company's framework for a strong free cash flow recovery could be at risk.

GS Factor Profile

The Goldman Sachs Factor Profile provides investment context for a stock by comparing key attributes to the market (i.e. our universe of rated stocks) and its sector peers. The four key attributes depicted are: Growth, Financial Returns, Multiple (e.g. valuation) and Integrated (a composite of Growth, Financial Returns and Multiple). Growth, Financial Returns and Multiple are calculated by using normalized ranks for specific metrics for each stock. The normalized ranks for the metrics are then averaged and converted into percentiles for the relevant attribute. The precise calculation of each metric may vary depending on the fiscal year, industry and region, but the standard approach is as follows:

Growth is based on a stock's forward-looking sales growth, EBITDA growth and EPS growth (for financial stocks, only EPS and sales growth), with a higher percentile indicating a higher growth company. **Financial Returns** is based on a stock's forward-looking ROE, ROCE and CROCI (for financial stocks, only ROE), with a higher percentile indicating a company with higher financial returns. **Multiple** is based on a stock's forward-looking P/E, P/B, price/dividend (P/D), EV/EBITDA, EV/FCF and EV/Debt Adjusted Cash Flow (DAFCF) (for financial stocks, only P/E, P/B and P/D), with a higher percentile indicating a stock trading at a higher multiple. The **Integrated** percentile is calculated as the average of the Growth percentile, Financial Returns percentile and (100% - Multiple percentile).

Financial Returns and Multiple use the Goldman Sachs analyst forecasts at the fiscal year-end at least three quarters in the future. Growth uses inputs for the fiscal year at least seven quarters in the future compared with the year at least three quarters in the future (on a per-share basis for all metrics).

M&A Rank

Across our global coverage, we examine stocks using an M&A framework, considering both qualitative factors and quantitative factors (which may vary across sectors and regions) to incorporate the potential that certain companies could be acquired. We then assign a M&A rank as a means of scoring companies under our rated coverage from 1 to 3, with 1 representing high (30%-50%) probability of the company becoming an acquisition target, 2 representing medium (15%-30%) probability and 3 representing low (0%-15%) probability. For companies ranked 1 or 2, in line with our standard departmental guidelines we incorporate an M&A component into our target price. M&A rank of 3 is considered immaterial and therefore does not factor into our price target, and may or may not be discussed in research.

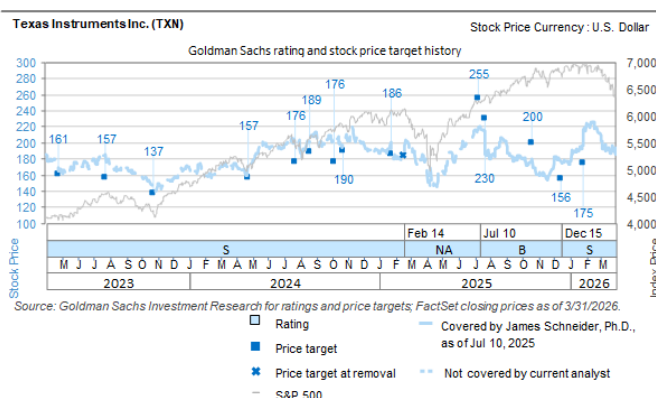
