

Nokia (NOKIA.HE): AI infrastructure build underpins upgraded Optical and IP outlook

In this note, we update our estimates and 12M PT to reflect the latest commentary on the underlying demand trends in Optical and IP Networks. Key points include **1)** Upgraded Optical/IP outlook reflects stronger AI-driven capex and improved supply visibility, **2)** Opex scaling to support Optical ramp and alleviate supply constraints, **3)** Infinera integration progressing ahead of schedule, with early commercial traction, and **4)** Flat RAN backdrop shifts focus toward software-driven value and returns. Remain Neutral.

- **Upgraded Optical/IP outlook reflects stronger AI-driven capex and improved supply visibility:** At its recent results, Nokia highlighted the material increase in hyperscaler capex expectations versus its 2025 CMD, with projected 2026 spend now exceeding \$700bn (vs c.\$540bn previously), reflecting the accelerating pace of AI infra build-outs. As AI adoption evolves, from early training workloads toward agentic and, longer term, physical AI, management expects a structural shift in traffic patterns, with machine-to-machine communication increasingly driving network demand. Management note that this is already visible in AI factory deployments, supporting growth both in data center interconnect and intra-data center routing and switching. Against this backdrop, Nokia now expects its AI and Cloud addressable market to grow at a 27% CAGR (2025-28), up from 16% previously, implying broader Network Infrastructure growth of 14% (vs 9% prior). This stronger demand outlook, alongside improved supply visibility across optical subsystems (including DSP components), underpins the upgrade to Optical and IP Networks growth expectations to 18-20% in 2026. The company also pointed to an order intake of €1bn from AI and Cloud customers in the quarter, with the segment accounting for 8% of group sales, noting extended lead times in Optical (12-18 months) reflect firm purchase orders with defined delivery schedules, thus supporting capacity planning and reinforcing confidence in the durability of underlying demand. As such, we have previously highlighted the growing significance of Optical in connecting AI data centers amid a compute constrained environment in our Nokia upgrade [note](#).

- **Opex scaling to support Optical ramp and alleviate supply constraints:** Nokia indicated that operating expenditure is increasing in tandem with efforts to capture the accelerating opportunity in Optical Networks, where supply remains a key constraint. Incremental spend is being directed toward R&D, sales and marketing, and manufacturing scale-up, alongside targeted capex to support fabrication capacity. Management emphasised that the current optical upcycle represents a step-change at the industry level, requiring not only capacity additions but also broader maturation of the supply chain and production processes. As such, opex investment is focused on securing critical components, improving manufacturing readiness, and scaling delivery capabilities. This reflects a wider industry dynamic, where demand continues to exceed available supply, necessitating coordinated investment across the value chain.
- **Infinera integration progressing ahead of schedule, with early commercial traction:** Nokia reported that the integration of Infinera is progressing smoothly, with synergy capture tracking at or slightly ahead of initial expectations. Management continues to target double digit operating margins for the combined Optical business and noted that early integration efforts are already yielding tangible benefits, both operationally and commercially. The two portfolios are viewed as complementary, supporting positive customer engagement and a number of early design wins post-acquisition. Importantly, Nokia signalled that current progress suggests scope to beat its initial synergy target of €200mn within three years of closing. Early impacts are beginning to flow through reported results, with integration execution remaining a key focus area. Overall, management highlighted strong alignment across teams and encouraging early evidence that the combination is enhancing competitive positioning in Optical Networks.
- **Flat RAN backdrop shifts focus toward software-driven value and returns:** Nokia characterised the broader telco and RAN market as structurally flat, reinforcing the need to identify alternative sources of value beyond traditional hardware-led capex cycles. Management pointed to two primary avenues: 1) enabling new monetisable services for operators and 2) evolving toward a less capital-intensive, more software-centric business model. In this context, Nokia continues to underline the transition to software-driven RAN, where innovation, spanning both features and performance enhancements, becomes increasingly decoupled from the underlying hardware layer. The company highlighted ongoing AI-RAN trial and customer engagement as early steps toward this architectural shift, which could reshape how baseband functionality is developed and deployed over time. Rather than positioning as a growth driver, management's focus appears to be on improving profitability and capital efficiency within a largely stagnant demand environment, with an emphasis on delivering more attractive returns through mix, software content and operational discipline. That said, we continue to look for further proof points on positive impacts from AI RAN given the need for standards to be built for this, per our industry discussions.

Changes to estimates

We raise our FY26-30 revenue estimates by c.2% to 3% to reflect the stronger-than-expected growth opportunities in Nokia's Optical and IP networks. As such, our growth rates for the outer years are broadly unchanged and the abs revenues are driven of a higher base in 2026 (and to some extent in 2027). Our gross profit estimates rise by +2% to 3%, broadly reflecting the changes to top line. For EBIT, our FY26-30 forecasts rise by c.3% owing to our latest assumptions on the top line, GM and operating leverage. Finally, our FY26 EPS forecast is higher by 5% driven by a higher one-time financial income contribution but our FY27-30 estimates are higher by c.0-1% reflecting our latest EBIT and share count assumptions.

Valuation and key risks

We are Neutral rated on Nokia with a 12-month price target of €8.9 / ADR \$10.4 (vs €8.0 / ADR \$9.2 prior) based on a 13x (vs 12x prior) CY27E EV/EBITDA (incl. restructuring) applied to our higher FY27 EBITDA estimates. As such, a higher valuation multiple is reflective of the better growth opportunities in AI indexed segments Optical and IP networks. Key risks to our view include faster/slower-than-expected growth in Optical and IP Networks; incremental profitability tailwinds/headwinds in the Radio Networks segment; and better/worse-than-expected cost control and planned investments related to capacity expansion, which could pose tailwinds/headwinds to absolute EBIT in a strong/weak top-line scenario.

GS Factor Profile

The Goldman Sachs Factor Profile provides investment context for a stock by comparing key attributes to the market (i.e. our universe of rated stocks) and its sector peers. The four key attributes depicted are: Growth, Financial Returns, Multiple (e.g. valuation) and Integrated (a composite of Growth, Financial Returns and Multiple). Growth, Financial Returns and Multiple are calculated by using normalized ranks for specific metrics for each stock. The normalized ranks for the metrics are then averaged and converted into percentiles for the relevant attribute. The precise calculation of each metric may vary depending on the fiscal year, industry and region, but the standard approach is as follows:

Growth is based on a stock's forward-looking sales growth, EBITDA growth and EPS growth (for financial stocks, only EPS and sales growth), with a higher percentile indicating a higher growth company. **Financial Returns** is based on a stock's forward-looking ROE, ROCE and CROCI (for financial stocks, only ROE), with a higher percentile indicating a company with higher financial returns. **Multiple** is based on a stock's forward-looking P/E, P/B, price/dividend (P/D), EV/EBITDA, EV/FCF and EV/Debt Adjusted Cash Flow (DACF) (for financial stocks, only P/E, P/B and P/D), with a higher percentile indicating a stock trading at a higher multiple. The **Integrated** percentile is calculated as the average of the Growth percentile, Financial Returns percentile and (100% - Multiple percentile).

Financial Returns and Multiple use the Goldman Sachs analyst forecasts at the fiscal year-end at least three quarters in the future. Growth uses inputs for the fiscal year at least seven quarters in the future compared with the year at least three quarters in the future (on a per-share basis for all metrics).

M&A Rank

Across our global coverage, we examine stocks using an M&A framework, considering both qualitative factors and quantitative factors (which may vary across sectors and regions) to incorporate the potential that certain companies could be acquired. We then assign a M&A rank as a means of scoring companies under our rated coverage from 1 to 3, with 1 representing high (30%-50%) probability of the company becoming an acquisition target, 2 representing medium (15%-30%) probability and 3 representing low (0%-15%) probability. For companies ranked 1 or 2, in line with our standard departmental guidelines we incorporate an M&A component into our target price. M&A rank of 3 is considered immaterial and therefore does not factor into our price target, and may or may not be discussed in research.

Quantum

Quantum is Goldman Sachs' proprietary database providing access to detailed financial statement histories, forecasts and ratios. It can be used for in-depth analysis of a single company, or to make comparisons between companies in different sectors and markets.

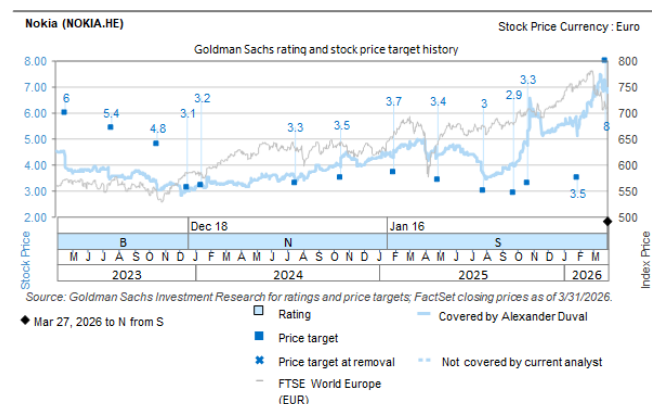

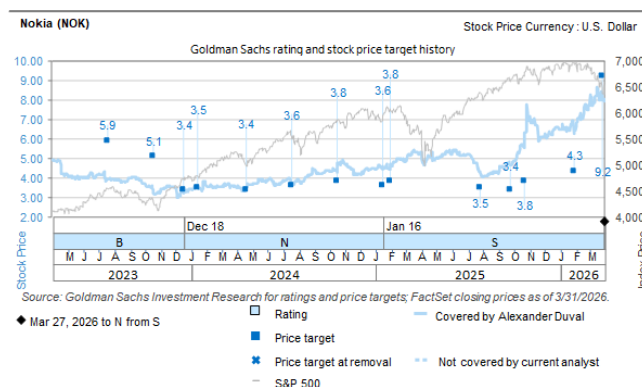
