

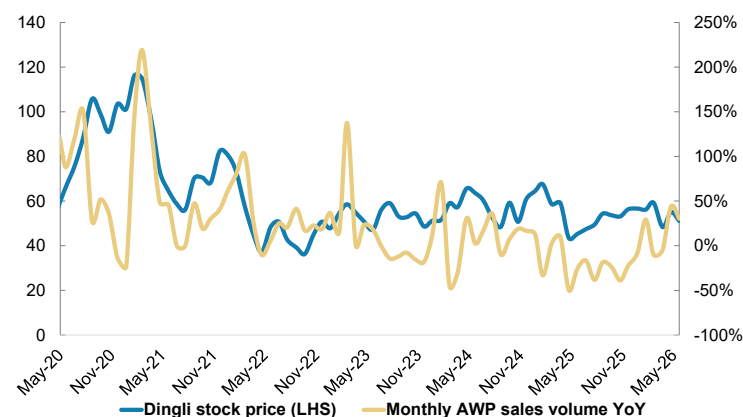

## China's Aerial Working Platform Sales YoY vs. Dingli's Share Price

**In May 2026, China's aerial working platform (AWP) sales increased by 30% YoY to 20.4k units.** Domestic sales recovery continued at +19% YoY to 6.3k units. Exports maintained momentum, up 36% YoY to 14.1k units.

**In 5M26, China AWP sales grew 17% YoY** (vs. -29% in 2025/+13% in 4M26), supported by robust exports (+35% YoY, accounting for 70% of China AWP sales), while the domestic sales decline continued to narrow (-12% YoY).

## Valuation Methodology and Risks

### Zhejiang Dingli Machinery Co Ltd. (603338.SS)

15x P/E multiple applied to 2026e excluding FX impact, as we think FX losses are a near-term impact and are largely priced in by the market. We view the multiple as justified - it is in line with -1 SD from the 10-year average forward P/E at 15x, in view of a weak domestic demand with high tariff exposure in the near term.

#### Risks to Upside

- Stronger-than-expected bargaining power stops margins from declining.
- Supply ratio to downstream rental companies increases more than we expect.
- Demand from overseas markets rebounds.

#### Risks to Downside

- Market share is lost as other OEMs put out more competitive products or compete sharply on pricing.
- Property investment and construction is weaker-than-expected.
